They are free of alcohol and do not contain aldehydes or phenols. The wipes can be removed individually from the practical and resealable dispenser.

Application

Wipe surfaces with CLEANISEPT WIPES until completely wet and allow to dry for the entire contact time. Medical devices that come into contact with the skin during intended use should be rinsed for 15 s under running water of suitable quality after the exposure time has expired.
